


## JOURNEY OF SHAKTI ORGANISATION

Focusing the local problems of shortfall in agriculture, education, health and socio-economic situation it has taken an integrated and innovative developmental approach to solve the problems of social and economic backwardness. Ever since its inception, the organization has touched many frontiers and evolved itself as a full-fledged development agency both institutionally and programmatically. Its intervention started with youth promotion programmes and today after two decade, it has broadened its scopes of work by venturing into women empowerment, childcare, old age care, livelihood security, environmental concerns, strengthening of Panchayatraj Institutions and owns the confidence of the community as well as the Government agencies. # **Old Age Care**

The Shakti Organisation has registered the suffering of the elderly with realization of loneliness, helplessness, and neglect, as the main cause and in order to address this, we are operating two Senior Citizen's Homes in Rayagada specifically for elderly people: the **Shakti Senior Citizen's Home** and **Matrushakti Senior Citizen's Home**. These two homes have a total capacity of seventy five residents together, supporting the needs of society in a very special way.

The main aim of our organization is to help the elderly through the virtues of love, compassion, and the very first of them humanity, and by creating a proper and healthy environment where the elderly individuals in need can find comfort and live with respect in the final stage of life. The facilities that are provided are very inclusive as they include in time food, safe drinking water, bed facility with mosquito net and regular health check up.

Our purpose is to make a pleasant environment where residents will feel that they are in the community and the pleasure of the mind, to its conclusion, is obtained. The residents of the resource center are given the opportunities for social networking and mental development through a number of activities like television watching, indoor games, the acquisition of newspapers, an evening stroll, and the observation of national days and festivals. Furthermore, the occasional excursions which are embarked on intentionally to constantly provide entertainment and also to shore up our residents' sense of belonging, through which, they feel a new bond with the surrounding environs, as well as with each other, are the other advantages the residents enjoy.

Our commitment to ensuring the well-being and happiness of the elderly is seen in our Senior Citizen's Homes where we provide holistic and caring support for our senior candidates. We continue to strive to be a society that nurtures respect and promotes empathy by means of offering our love and care to which our elders belong, that is, by the things they have done.

Overall, we at Shakti Organisation aim to develop a safe and loving environment for the older members of our society and respect them as they confide in us and show their individualities.




- Weekly Health Check Ups

# **Community Health Care**

One **Maternity Waiting Home** is functional at indigenous people dominated Kashipur block of Rayagada district covering 150 remote villages from 11 Sub centres of 9 Gram Panchayats to ensure hospital delivery of cases from the hard to reach regions. During the FY 2023-24 total 425 cases admitted in the Maternity Waiting Home including 239 cases of tribal communities those generally believe in superstitions and prefer home delivery..

All the cases successfully gave birth to healthy babies and enjoyed the service during their stay at Maternity Waiting Home. Through Village level awareness creation and linkage of Govt. Vehicle/Ambulance, cases 10 days before their delivery date are brought to Maternity Waiting Home with their escort followed by facilitation of Maternity Waiting Home staffs.



#### Facilities available at Maternity Waiting Home:

- Comfortable accommodation including availability of bed and mosquito net
- Balance Diet as per routine
- Availability of water purifier for safe drinking water
- Regular Health Check Up by expert-ANM
- Health Check Up at Hospital facilitated by Lady Health Assistants
- Counseling through visuals including pictures and videos
- Services of experienced lady staffs including one ANM and three Lady Health Assistants

Shakti has facilitated the Mass Drug Administration programme for elimination of lymphatic filariasis in the whole Rayagada block of Rayagada district covering 26217 households in 351 villages through engagement of Community Mobilizers to conduct community awareness meetings on intake of drugs for elimination of lymphatic filariasis.



Shakti has also been registered as Nikshya Mitra under the 'Pradhan Mantri TB Mukt Bharat Abhiyan' to provide support to TB patients undergoing treatment for which 5 TB patients from Kashipur block of Rayagada were provided with rations including rice, pulses, ground nuts, oil, egg, soya chunks, and wheat flour for six months as per the Govt. norm to fulfill their nutritional requirements.










Shakti has actively involved in the **Tobacco Control Campaign** by conducting six block-level awareness programs on the health risks of tobacco and the need for its control. These sessions engaged 275 PRI members (Sarpanch) as participants from five blocks of Rayagada: Gudari, Padmapur, Muniguda, Chandrapur, and Bisamkatak.

## Livelihoods, NRM and Infrastructure Development


Odisha PVTG Empowerment and Livelihoods Improvement Programme (OPELIP) is implemented at Muniguda and Puttasing area of Gunupur block covering the PVTG communities like Dangaria Kandha and Lanjia Soura. Here the main interventions are livelihoods including agriculture, non-agriculture income generation activities, NRM activities and Infrastructure developments. Odisha Tribal Empowerment and Livelihoods Programme PLUS (OTELP PLUS) is similar kind of Programme implemented at Ramanaguda Block which includes agriculture, non-agriculture income generation activities and NRM activities through MGNREGA Scheme. Through the Odisha Millet Mission Project we are focusing on promotion of millets in Ramanaguda Block. All these projects are implemented involving Community Based Institutions like Village Development Associations (VDA), Self Helf Groups (SHG), Farmer Producer Organisation (FPO). The farmers are strengthened through Capacity Building Programmes like Trainings, Exposures, Workshops, Food Festivals etc. and supported with seeds, seedlings, bio-inputs and incentives as part of programme activities. We always prioritize on adaption of organic manure instead of chemical fertilizers for which we conducted trainings on organic manure preparation like Jeevamrit, Beejamrit, Pot manure and supported for Vermin-Compost units and compost pits.



#### **Involvement with CBOs**



Shakti is implementing Capacity Building Prograames of REWARD Project (Rejuvenating Watersheds Agricultural Resilience through Innovative Development) at Jujomura Block of Sambalpur District as DLSA (District Level Supporting Agency). This project involves developing training modules and training calendar, as well as conducting qualitative training programs for the Watershed Committee members. During the reporting period 13 Training Modules prepared with conduction of 4 Training Programs covering 570 participants.






Besides the Agriculture activities 15 nos. of Individuals and 21 SHGs were supported with Income generation activities with coverage of 1790 beneficiaries at programme area of Ramanaguda, Gunupur and Muniguda Block. These activities include Goat Rearing, Poultry Unit, Piggery Unit, Layer Bird, Processing Unit, Grocery Shop, Tailoring Unit, Xerox Shop, Computer Centre and Stationary Shop etc.






Individual Supports were provided to Ultra Poor/ Poorest of Poor families as decided by the community to enhance their livelihoods through Income Generation.

Through the OPELIP and OTELP PLUS Project we are implementing community development activities including Natural Resource Management & Infrastructure Development.











# Women Empowerment

In partnership with Trickle up India Foundation, we are implementing MPOWERED Scale Up project to empower 1,200 ultra-poor women living in extreme poverty in the Ramanaguda Block of Rayagada District through mobilization, strengthening and support of women SHGs. The project seeks to enhance livelihoods, improve access to financial services, and foster greater participation in government programs. Through this project a cadre of 20 Smart Sakhis has been strengthened through capacity buildings who are working as mentors to regularize SHG activities including SHG meetings, savings, record keeping etc. Through the MPOWERED Project we are directly working with 96 SHGs for their sustainability through their capacity building, developing business plans, small hand hold supports and linkage with Government schemes. Besides MPOWERED Project through OTELP PLUS, OPELIP, OMM project women participation in programs, involvement of SHGs for Micro Enterprise activities supported through the projects are some of the activities meant for Women Empowerment. The capacity building programs are designed to strengthen the women in leadership development, decision making, record keeping & business plan preparation.

# **Land Rights**

Shakti has been implementing Forest Rights Act 2006 which is also called Scheduled Tribes and other traditional forest dwellers (Recognition of Rights) Act. During 2023-24 Odisha Government has launched Mo Jungle Jami Yojana (MJJY Scheme) for smooth implementation of the Act to provide maximum benefit to the eligible claimers of forest rights. With the support of Foundation for Ecological Security (FES) we have been implementing the project in 3 blocks Gunupur, Ramanaguda and Padmapur blocks of Rayagada district in liaison with MJJY Scheme involving Line Departments.

Total 160 CFR (Community Forest Rights) claims and about 4000 IFR (Individual Forest Rights) claims submitted from above 3 blocks of Rayagada for settlement of forest rights through facilitation of claim procedures including conduction of Gramsabha meetings, Forest Right Committee formation and relevant document preparation etc.

# **Child Rights**

Through 2 projects we have addressed child protection issues one is the CHILDLINE Project implemented in Rayagada district, another is the Access to Justice for Children project implemented in Rayagada and Kalahandi district. Through these projects we aimed to provide justice to the children by combating against child labour, child trafficking, child

marriages and child sexual abuse cases.

We have conducted awareness meetings and pledge taking activities against child marriages in 300 villages and 200 Institutions, 2 nos. of street rallies, 400 Poster posting at village and religious places, message display through mascot in district festival for awareness creation. The major activities are summarized in below tables.

### **Education**

Shakti operates the **Balashram**, a secondary hostel for boys in Rayagada, with a capacity of 100 beds, supported by the Ministry of Social Justice & Empowerment. The Balashram is designed to provide a nurturing environment for the holistic development of students, offering essential facilities such as accommodation, nutritious meals, tuition facility, health checkups, sports equipment, providing uniform & study materials, safe drinking water through water purifier.

During the fiscal year 2023-24, 100 underprivileged Scheduled Caste (SC) students were admitted in Classes IX and X. To promote physical well-being, we conduct morning yoga and exercise sessions every Sunday, alongside regular health checkups managed by visiting doctors, with individualized health profiles maintained for each student.

We also maintain a well-equipped First Aid Box for immediate medical needs. To foster creativity and cultural expression, we organize recreational programs, including singing and dancing during holidays. A structured daily routine instills discipline and security, creating an enabling environment for our students to thrive academically and personally.






# **Awareness on Road Safety**






Pledge taking to follow road safety rules


