

#### Welcome to the Shakti's Annual Report 2015 - 2016

This report provides an overview of our work in the areas of Health and Nutrition, Education, Child rights and women empowerment in the district of Rayagada.





# 1. SHAKTI VARTA – Participatory Learning Action (PLA) Model with Self Help Group (SHGs)

Shakti Organisation in partnership with the DFID sponsored Technical Management Support Team (TMST),

implemented the Shaktivarta programme in all villages of Rayagada District. This PLA approach was the central methodology of **Shaktivarta**, designed with the technical assistance of TMST and EKJUT in coordination with DWCD, DoHFW, DRD, and DFID. The PLA cycle consists of 20 meetings arranged into two mini-cycles of reflection followed by the evaluation of both the cycles, the first on maternal and newborn health, and the second on nutrition and WASH. In addition to the 20 SHG meetings, the Shakti Varta SHG facilitates a community meeting and participates with other Shakti Varta groups in a Gram Panchayat (GP) level meeting. The PLA meetings were conducted in an interval of 15 days. The facilitators were trained at five intervals across the span of the PLA cycle to learn about the meetings, methodologies to be followed





during the SV meetings to discuss and solve issues coming up from the community using engaging interactive tools such as story-telling, picture cards and games. This programme was implemented by a DPC at the district level, 22 BC and 11 BFCs were appointed and placed at the respective ICDS offices. Along with that 11 ICDS BC and 11 Block level Federation BC were nominated by respective ICDS and Block Federations. PLA meetings are delivered by nominated 342 SHG Member Facilitators (2 per GP) and each covers a maximum of 10 SV points. The fortnightly Shakti Varta meetings were organized for 1.5 to 2 hours in duration. SHG members and other women and men in the community, particularly pregnant and lactating

women, women with children below two years, and adolescent girls were the project participants to attend the Shaktivarta meetings.

## **Objective**

Reduction of IMR, MMR and Malnutrition by promoting positive health seeking behaviour among the community Institutions i.e. SHG

#### **Positive Impact of Shakti Varta:**

Organising Shakti Varta meeting at village level, the positive changes slowly happened at community by the empowering HNWAS. The positive changes captured in the meeting by the discussion with community. i.e. use of bed net, use of latrine, hand washing in six methods, increase the institutional delivery etc.

Mrs. Namita Hikaka (22), Schedule Tribe was resided at Pujariguda village of Suri GP of Kolnora Block. Due to the financial crises she could able to complete the 2<sup>nd</sup> standard. The village was situated between the hills with a 5 Km distance from the main road connecting to her village. Mrs. Hidaka's financial condition was very poor. Her family's major livelihood was agriculture.

She gets married in 2015 and she was pregnant though she was not prepared for the same. As this was her 1<sup>st</sup> baby, she had no idea about the antenatal and postnatal care. She was found by the SHG (M) Facilitator Mrs. Satyabati Hidaka's during her home visit to inform the women for the PLA meetings. That time she was 5 months pregnant but not received any services from AWC because her name was not registered at the AWC. Immediately, Satyabati (GPF) helped Namita in registering her name and avail required services available for the Pregnant Women. Since then she was also advised to attend the Shakti Varta meetings and she use to attend all the meetings.

After completion of Shakti Varta Meeting-8, she knew about the 3 delays and its contribution to maternal and infant death, preparation of delivery kits, New born care like wiping, curd care, wrapping, initiation of early breast feeding, delayed bathing, exclusive breast feeding, positioning etc.

At the time of 12<sup>th</sup> meeting, it was found that Namita had already prepared the delivery kit; written the emergency contact number of ASHA, 102/108 Ambulance etc. as she has planned give birth her baby at the hospital. While asking about the same "Sunita replied, I had heard about the 3 delays and its consequences so, now I am ready in all respect to give birth my baby". Since then she was acting as a motivator for others and now also having healthy baby with B/W 3.000Kgs.

# 2. Training and Capacity Building Activities

# (A). Inter Personal Communication (IPC) training to ASHA: A tool for effective counselling

Mobile Kunji as an approach under Shaping Demand and Practices project was implemented by BBC Media

Action and Care-India. This is a simple, convenient audiovisual audio visual job aid for community health workers (ASHAs and AWWs) to promote and provide information on 9 life-saving maternal and child health behaviours. Mobile Kunji ('Kunji' is roughly translatable as 'Key' or 'cheat sheet') is a book look alike a mobile phone consisting of a light, sturdy deck of laminated cards with a steel ring. The cards are printed with required information relevant to various stages of life like family planning, pregnancy and postnatal care for children up to two years. The information covers



eight life-saving behaviours, and over a hundred arguments for life-saving attitudes, norms and beliefs. SHAKTI trained 96 ASHAs/AWWs in 3 batches for Ramnaguda, Gudari, Padmapur and Gunupur Blocks.

# (B). Capacity Building of ASHA on HBNC:


Accredited Social Health Activists (ASHAs) are being deployed for every 1000 population to cater basic health



and nutrition services to the rural poor and also act as a link between the community health care and end users. Home Based Newborn Care (HBNC) was always being an important tool measure the health condition of both mother and newborn baby through 7 home visits since the day of delivery to 42<sup>nd</sup> day. Shakti Organization was assigned to

undertake the Training of ASHA 6th & 7th training Module 4 round to skills. develop the skill on Mother & child health care by National Health Mission, Rayagada. Total 442 ASHA of Ramnaguda, Kolnora and Bisama Cuttack were trained in 14 batches at the Shakti Training Institute, Ramnaguda. In the training programme, the ASHAs were encouraged to reach out to those un-reached in their respective community as they are neglected and prone to both major and minor consequences of disease due to their vulnerability.

3. Social Drive on Child and Maternal Health:



facilities

Shakti organization has initiated an innovative approach with the support of National Health Mission,



Rayagada to promote positive health seeking behaviour by reaching to the out-reach pocket of Ramnaguda Block. In this programme, 756 households have been covered in 20 villages. As far as innovative approach is concerned, Shakti has

organized 20 mass community meetings, 20 IEC/ BCC activities through flex display and organizing play i.e. Daskathia and 20



health check-up camps to identify the illness of all children and Pregnant Women and Lactating mothers. Through this program Shakti has reached to 100% target population within a period of 6

months. In this financial year 13 Sub-Centers of 20 villages were covered in Ramnaguda Block.

## 4. Gaon Swasthya Samikshya (GSS):

Gaon Swasthya Samikshya Programme which is also known as Community Monitoring of health services under NHM Odisha. Shakti was selected as District Coordinating NGO for the district to implement this programme. Out of 11 blocks Shakti was implemented this programme activities directly with the FLWs in 8 blocks whereas in 3 blocks the programme was implemented with the help of local NGOs like Prepare was working at Kolnara, ALISHA was working at Gunupur and NVCT was working at Bisama Cuttack. Community-based action of health services is a key strategy of National Health Mission (NHM) to ensure basic health services are reaching to the poor, women and children. It encourages community led action, where people will monitor and assess whether the health needs and rights of the community are being fulfilled. SHAKTI Organisation was implementing Gaon Swasthya Samikshya (GSS) in Ramnaguda Blocks to strengthen Gaon Kalyan Samity (GKS).

#### 5. Free Ambulance service:

SHAKTI as not for profit organization and has been working with the people for their upliftment since 1992. In Rayagada district the ambulance service is very poor due to its geographical situation. Many poor people are not accessible to the ambulance service provided under government programmes. Looking in to the same Shakti has been engaging a free ambulance with the philanthropic support from State Bank of India, Rayagada. The emergency health care service was provided on 24 x 7 for the under privileged population at the same time other section of people can avail the same services by paying the fees as per the government rate.




Ambulance Services



- 1. Total 398 cases were transported within district whereas 19 cases were transported to Seven Hills Hospital, Visakhapatnam.
- 2. 11 Pregnant Women and 39 Children under 1 year have transported to the district HQ hospital
- 3. 15 general public have availed this ambulance services by depositing the fee as per the government rate.

#### 6. Health-ARSH:

SHAKTI with the support of Child Fund International, USA, implemented health programme with special focus on Adolescent Reproductive sexual health (ARSH) in 36 villages of Kolanara and Rayagada block of Rayagada Dist. Knowledge on ARSH was imparted to 738 adolescent girls. Focus was given on behavioural change and practices. 33 Trainings on ARSH, 25 Training on Mensuration Hygiene and 30 nos. Street Play on early marriage were conducted during 2015-16.



## ORISSA TRIBAL EMPOWERMENT AND LIVEIHOOD PROJECT (OTELP)

Rayagada District is full of forest and its maximum lands are covered in hills. Communities are basically depending on the cultivation, domestic animal rearing, collection of seasonal NTFP and as daily wage labour sometimes they use to migrate to the other state in search of their livelihood. In spite all these options, sometimes they failed to get a square of meals. Looking in to the above condition, SHAKTI in collaboration with OTELP has initiated technology based enterprise farming through building the skills of local youth and promotion of different micro enterprise/ business in Kashipur Block. Value-addition in to the local products and shape it to the market demand and marketing linkage.

**GOAL** 

Ensure livelihood and food security among poor tribal households through promotion of a more efficient self-managed and sustainable exploitation of the Natural Resources and through off farm/ non-farm enterprise development.

#### Strategies:

- A. Building the capacity of marginal group as individual and grass root institution.
- B. Enhance the access of poor tribal people to land water and forest and increase the productivity of these resources in environmentally sustainable and socially equitable ways.
- C. Encourage and facilitate off-farm enterprise development focused on the needs of poor tribal households;
- D. Monitor the basic food entitlements of tribal house and ensure their access to public food supplies;
- E. Build on the indigenous knowledge and values of tribal and bland these with technological innovations to ensure a speedier pace of development.

#### **Natural Resource Management Activities 2015-16**

Under this intervention diversion based Irrigation system were constructed through canal, check dams and

pipe to provide irrigation to 100 Acres of land of 100 beneficiaries in 5 villages with an expenditure of 33.98 lakhs.





#### Social interventions 2015-16

Under this intervention low cost house (10) and toilet & bath room (56) were constructed in 4 villages with an

cost of Rs.18.22 lakhs in K.Marapas, Podapadar, Kantamal and Adatakiri village of Kasipur Block.

#### **Livelihood Promotion activities:**

This particular activity was undertaken with a convergence and inter sectoral coordination approach, where along with OTELP, NFSM, Agriculture department and National Horticulture Mission were involved to support the desired farmers on Commercial vegetable cultivation through Trellis

# SUSTAINABLE LIVELIHOOD ENHANCEMENT AND ENTERPRISE PROMOTION (SLEEP)

This project was implemented in 17 villages of Ramnaguda blocks with the support of Rastriya Gramina Vikas Nidhi (RGVN). 400 tribal women were involved in this sustainable nature of livelihood support system. Women mostly dependent on on the forest produces are the project participants of this project. The project components were channalized through women cooperatives called producers company. This producer company members were trained on the value addition componets based on the market demand to their existing produces. By the regular guidance of staff, upgraded the skill. In this year 2015-16 season, total 3.20 quintal Tamarind had processed in to cake as finished product and 1.25 quintal products were marketed in high price. This has motivated them to start up their business in a new form.

#### **Objectives of SLEEP:**

- Mobilizing women forest dwellers to form producer groups and improving their skills and capabilities on value addition activities in to NTFP produces.
- Facilitate the process to access to fair and remunerative markets including establishing linkage between producer groups and market aggregators
- Enable women to have better access to inputs and schemes of the government and other agencies within a convergence and Linkages framework
- To promote producers company/ cooperatives in Odisha to increase their business volume









# **Community Forest Right:**

Community forest rights recognized under the Forest Rights Act are important for securing livelihoods of the forest communities and for strengthening local self governance of forests and natural resources.

Rayagada is a forest surface land. Most of land comes under forest. Basically community depends on forest to ensure their livelihood. By the facilitation of SHAKTI, Village Forest Committee & Community of Sundhidhamuni, Parikhiti, Gulunti, Gogoupadu, G.Gulumunda GPs applied the claim for CFR. It will help to the community for use and disposal of non-timber forest produce (NTFP), and rights over the products of water bodies and grazing grounds, are referred to as Community Forest Rights or CFRs.

SHAKTI has sensitized to community at 40 no of villages in 5 GPs as a result total 38 no of villages out of 40 villages completed the phase 1 & 2 Palli Sava and produced the document at Sub-Divisional level for provide the CFR. Sebajagat supported for this campaign.

# **Child Development Programme:**

Children are the future citizen of the country. By defination, child those have attained below the 18 year of age. Child Right and child protection Act says, every child has the right to survival, protection, development and participation. To provide the security to the child is the duty of their parents but still it is a matter of concern where children are being neglected by their parents and gardians and it increases their vulnerability.Loking in to the past scenario, current practices both in rural and urban areas, Shakti has been working in this in partnership with Child Line and Child Fund India to protect their rights to secure their future.

#### CHILDLINE RAYAGADA

The CHILDLINE is 24 hours (night & day) free phone outreach service can be accessed by a child in distress

or anybody on behalf of the child can dial 1098 and the CHILDLINE officials will reach to provide emergency assistance to a child. The CHILDLINE service focuses on the needs of children living alone on the streets, child laborers working in unorganized sector, domestic workers and sexually abused children. The child is rescued & referred to an appropriate organization for long-term follow up and care. Shakti Organisation, being the collaborative organisation of CHILDLINE for Rayagada District, its intensive focus was Rayagada & Ramnaguda



#### **Focused Intervention**

In this year total 71 awareness programmes, 26 Community meetings were conducted

Block but also catter services for whole district.

As per the record, Shakti ogranisation has received 2820 calls from every corner of the district within a period of one year (April'2015 to March'2016). As per the requirement, 10 types of

calls are being reported i.e. Intervention (340 calls), Missing Children (12), Immotional support and guidance (409), Unclassified, information (943), Supportive (908), Technical diffects (19), Fun calls and others (574).



## Observation of World day against Child Labour


12<sup>th</sup> June is the World day against child labour was observed in JKPur by the CHILDLINE-Rayagada where all

the slum children were sensitized on the child rights and the emergency toll free telephone no. **1098**. The observation of the day was started with a rally by 50 children with banners, placard and slogans on child rights and against child labour. The program was chaired by Mr. Pratap Naik, Childline member. In his speech he shared about the child rights, rights to education till 14 years among the parents present in the meeting. At the end of the day everybody took an oath to avoid the child from labour and dial 1098 in case of any emergency.



# Shakti Child Development Programme

Shakti in association with Child Fund India is implementing child development and protection programme for the DEV (Deprived, Excluded & Vulnerable) category of population irrespective of caste, creed and religion in 36 villages covering 928 children of Rayagada and Kolnora Block.



#### Vision

In Rayagada, where the disadvantaged, discriminated and excluded child is supported and enabled to grow up and playing an active and positive role within the family, community and nation

Child fund programme was implemented life stage wise i.e. Life Stage-1, Life Stage-2 and Life Stage-3 and covers 0 to 24 year age group of DEV population. Life stage specific activities were designed and implemented to ensure their safety, security. education, nutrition and livelihood. During this FY 2015-16. various age appropriate and need based activities have planned and complete the desired result. To achieve the Life stage wise objectives, activities were designed for various category of children SAM, MAM, Community Institutions like JC/ MC. AWW/ ASHA/ ANM, Teachers. SMCs PRIs and Child clubs.


#### Education support to 300 slum children of Rayagada

To develop and enhance the educational standard and life skill knowledge of poor and educationally weak students of Slums of Rayagada Town of Odisha, India by creating opportunities for additional learning facilities by way of special coaching of 300 students of poor economic background of 12 slums, Shakti has started 12 beyond school learning centers. Our basic aim is to build the capacity of students in education and life skills and Child rights. These centres enrolled 300 children of marginalized community, out of them 125 are girls and 175 are boys. During the last quarter our Programme has shown some good result, all students passed in their annual examination. 23 students stood within the best tenth in their classes, 46 students got position among first 20 good performers in annual exam in their classes. We have conducted 12 nos of parents and teachers meetings to involve the parents to boost the morale of their children and check drop out from coaching classes. All students are regular in their schools and the drop out is checked, but we found 14 dropout from our coaching classes. 206 students have made improvements in their annual examination. In addition to educational focus, we also emphasized on personal hygienic practice of students, nail cutting and hand wash practice. To support the programme, we are mobilising fund from individual and institutional donors, in partnership with Global Giving.

## Dignity and Security in one's old age

India, the second most populous country in the world, has a booming population of above one billion people. This, along


with an improvement in life expectancy, has led to an increasingly large number of people over the age of 60. The majority of them are very poor and residing in rural set ups. The elderly have little hope of escaping poverty and their situation only becomes worse as they get older and are increasingly plagued by chronic health problems. Impoverished elderly women face a particularly difficult situation, especially those who are widows. Given their low rank in society, their inability to work can mean they are unable to survive on their own.



#### **Old Age Home:**

SHAKTI has been working on the issues of senior citizens for the last twelve years to foster the welfare of the aged especially the needy aged, irrespective of cast or creed and to create in the younger generation and in society a social awareness about the problems of the elderly in today's Society. As a part of its effort for senior citizen, SHAKTI began

working on two types of initiative i.e. **Institutional and Non- institutional** care focusing on the elderly people in the Rayagada District. There is a project management team consisting of Project Co-ordinator (One) for overall management of day to day activities followed by Counsellor (One), Midwife-cum-peon (One) and Visiting Doctor (One). All the staffs are well trained, experienced with their respective job descriptions and very much sympathetic towards the inmates

# **Comprehensive Programme on Land Rights**

Recognition of tribal rights of the Tribals has been a gray area in the history of land rights. There is a high demand in the

rural community to settle the cases of landlessness. Shakti Organisation is proud to be the partner of this programme with ST and SC Development Department under Article 275(1). This land rights programme was launched in June'2014 and implemented in Kashipur Bock of Rayagada district with the support of Integrated Tribal Development Agency (ITDA) and technical assistance from Rural Development Institute (RDI). Land to landless in a time bound manner is the prime objective this programme. This programme has launched in June-14 in Kasipur Block.



**Outcome** 

84 local youth has been identified as Bhumi Sanjojaka and trained to facilitate the process.

Village application for Community forest rights of 10 villages submitted

17 Homestead less household got homestead land of 1.07 acres and 27 landless households got 7.47 acres of agriculture land

#### Shakti Varta:

Supported by IPE Global Pvt. Ltd, Bhubaneswar aims to improve the quality life of the people especially the deprived, marginal and vulnerable community (Women and Children) by promoting positive health seeking behaviour in Health, Nutrition and Water, Sanitation and Hygiene. Introduction of PLA approach in mobilizing and promoting the community to generate demand and fixing accountability on FLWs was major impact of the programme.

# IPC Training/ SHG Training/ Social Drive/ Gaon Swasthya Samikshya:

Supported by National Health Mission (NHM) Rayagada aims at to improve the quality service delivery both at the reachable and out of reach areas in addition to that the objective is to empower the community members mostly Women and community institutions to monitor the service quality in terms of maternal and child health.

# Orissa Tribal Empowerment and Livelihood Project (OTELP)

Supported by SSD department, Government of Odisha to promote livelihood options for the Schedule Tribe (ST) most deprived community in the society. Along with the livelihood generation, various construction activities are being taken up to support the livelihood system.


