
## JOURNEY OF SHAKTI ORGANIZATION:



**Operational Area-**Tribal dominated fourteen villages of Sindurghati, Sunger and Adajore GP of Kashipur Block, Dist- Rayagada

- Total 20 hectares of mixed plantation (Mango+Cashew) was taken during 19-20 under MGNREGA Scheme covering 79 benefitted people in 4 villages of Adajore and Sunger GP. The farmers were supported with grafts, manure and tree guard for sustainability of the plantation.
- Total 20 hectares of 2<sup>nd</sup> year maintenance was taken for mixed plantation (Mango+Cashew) covering 88 beneficiaries in four villages.
- Total 3 nos. of check dams constructed in 3 villages covering an ayacut area of 31 acres with 43 benefitted farmers.
- Total 3 nos. of farm ponds constructed in 3 villages covering an ayacut area of 30 acres with 40 benefitted farmers.
- Total 18 nos. of compost pits constructed in 5 villages covering 70 benefitted people.
- Total 7.5 acres of land was covered with field bond activities with 22 benefitted farmers.

### Capacity Building-

Total 31 nos. of Awareness, Training Programme and Exposure visit were conducted in different Programme villages of OTELP PLUS area during FY 2019-20 including both community empowerment and beneficiary skill up-gradation. The theme of the CB Programmes covered Animal health Camp, Human Health Camp, Krushaka Samparka Mela at Panchayat level, Awareness on sanitation, village cleanliness, use of toilets, awareness to parents to check dropped out children, Income generation training on NTFP, Orientation on Govt. schemes, Management practices of goatery, poultry, Training on SRI/Line sowing, low cost technology, compost preparation and Exposure visit to see best practices. Mass Immunization of livestock conducted at Programme villages during Animal Health Camp to eradicate viral diseases and to aware people for immunization. Government officials from different sectors like BVO, WAO, Doctor, ANM, Agriculture Overseer, Forester, Livestock Inspector, and Social Worker with expertise participated as resource person and all most all the Programmes were conducted through participatory process with a session for interaction and question answers. Showing videos, posters, and pictures has more effect on rural village level audience rather than only lectures for which such methods were also followed for effectiveness of the capacity buildings of the laymen.

## ODISHA TRIBAL EMPOWERMENT AND LIVELIHOODS PROGRAMME PLUS (OTELP PLUS), Ramanaguda

OTELP PLUS Project was introduced at Ramnaguda Block in the FY 2018-19 for livelihood enhancement and food security of poor tribal households of Ramnaguda Block.

Operational Area- Covers 6 GP such as Parikiti, Gulunthi, Gogupadu, Boothing, Gosei Golumunda, Penkan and includes total 38 villages.

### Activities in the FY 2019-20:

#### WADI Plantation:

WADI Plantation of Cashew and Mango was covered in a total area of 123.5 Acres of land including 76 nos. of benefitted farmers at 4 villages of Ramnaguda Block by the support of SHAKTI-OTELP PLUS, Ramnaguda under MGNREGA Scheme. They were supported with qualitative grafts, manures, tree guards and labour cost for smooth implementation and sustainability of the plantation. The village wise covered area and beneficiary numbers given in below table.

## **CENTRE FOR WORLD SOLIDARITY (CWS)**

SHAKTI- CWS Project playing important role in livelihood enhancement of indigenous tribal people through organic farming, kitchen garden development, negotiating people with schemes of Agriculture and Horticulture Department and providing small handhold supports like supply of inputs such as vegetable seedlings, mandava weeder, plastic baskets etc. Apart from this it plays role in empowerment of people through capacity building of community with themes of schemes of Agriculture, Horticulture Department, organic farming, mushroom cultivation, SRI method of cultivation, trellis method of cultivation and conduct exposure visit of farmers to see best practices and to gain knowledge through observation. Activities of this Programme are implemented at two GP Tadama and Gajigaon of Rayagada District covering 14 villages where more than 90% people belongs to marginal scheduled tribe and scheduled caste community. During FY 2019-20 hundred two families are supported with kitchen gardens. They are supported with brinjal, tomato, chilli, cauliflower are marginal, cabbage, banana, drum stick, papaya, jack fruit, ivy gourd, pointed gourd seeds, seedlings and tubers for development of kitchen gardens to enrich people with nutrition at their back yards. Inputs like 50 nos. of compost pit, 30 nos. of mandava weeder, 49 nos. of plastic crate, 5 nos. of pump set are also supplied to farmers in the Programme Area. Devices are supported by formation of farmers groups for better utility at community level. Besides this community are supported for getting benefit of various Government Schemes like MGNREGA, MAMATA, PMAY, PM KISHAN YOJANA etc. through facilitation of SHAKTI-CWS staff. No doubt implementation of this project improved the livelihood pattern of rural tribal mass especially in agriculture activities beyond their traditional practices. The epitome of activities of this project for FY 19-20 is given in below table.

## **Odisha PVTG Empowerment and Livelihood Improvement Programme (OPELIP):**

### **Goal:**

Overall goal of this Project is to achieve enhanced living conditions, to reduce poverty of the target group households, enabling improved livelihoods and food and nutrition security primarily for PVTGs households, building the capacity of the target households, Securing entitlements over land and forest, improving agriculture practices for enhanced production, Promoting income-generation, micro-enterprises for alternate livelihoods, ensuring access to education, health and other services and improving community infrastructures. PVTG includes Lanjia Soura of Putasing and Dangaria Kandha of Muniguda Blocks.

**Operational Area-** Two block Putasing, Muniguda of Rayagada District. Two GP of Putasing such as Sagada, Abada covering 8 revenue villages and 12 hamlet villages and two GP of Muniguda such as Munikhol, Sibapadar covering 56 revenue and 16 hamlet villages.

**Major Activities-** Community Empowerment, Natural Resource Management and Livelihood Enhancement, Community Infrastructure and Drudgery Reduction

### **Activities at Muniguda Cluster-**

Priority has always given for livelihood enhancement of the vulnerable communities like poorest of poor, physically handicapped, BPL, widow, destitute and marginal women through SHG. They were supported with several income generation activities through this project. The details of the support given has mentioned in below table.

### **Case Study:**



The poorest of the poor women Mrs. Jamuna Ambadi aged about 58 years old lives in OPELIP Project Operational village name Kudulima closely located in nearby Hatadahikhal village under Sibapadar Grampanchyat of Muniguda block of Rayagada district. Village Kudulima is 12 Km distance away from Muniguda block head quarter and 35 km away from DKDA Chatikana office and 85 km away from District Head Quarter Rayagada.

The main occupations of the villagers are cultivation & daily wages and Maximum are BPL categories out of them Mrs. Jamuna Ambadi was selected for this support by the Gramya Unnayana Sangha as she and her family were too needy for a support to start income generation activity. With the support of IFAD through OPELIP Project under DKDA, Chatikana and facilitated by staffs of SHAKTI she was sanctioned for a grocery shop with a provision of Rs.27000.00. She started her grocery shop and her daily selling used to 1500-2000/- on average. With own interest and endeavour she has been started to sell locally available vegetables along with grocery items at her shop. Now the shop is needful for the community and Mrs. Jamuna Ambadi become able to obtain a sustainable livelihood through this shop.

### **Capacity Building Programme:**

Total 35 nos. of capacity Building Programmes conducted during FY 2019-20 for CRP and SHG members on the themes of Book keeping, Annual Work Plan Preparation, Financial Literacy, Social security schemes, Community mobilization including one exposure visit.

### **CSR INTERVENTION:**

In view of building a better and sustainable way of life for the weaker sections of the society, SHAKTI has got an opportunity to implement livelihood promotion activities under CSR project of Utkal Alumina, Tikiri, Rayagada. We are involved in following activities.

Janaseba Trust- We have shared professional staffs with Utkal Alumina Janaseba Trust for the implementation of WADI plantation activities in Kashipur Block.

UAIL Farm Based Livelihood- We have shared professional staffs with Utkal Alumina UAIL for implementation of farm based livelihood activities at Kashipur Block.

UAIL Non-Farm Based Livelihood- We have shared professional staffs with Utkal Alumina UAIL for implementation of non-farm based livelihood activities at Kashipur Block.

### **CHILDLINE, RAYAGADA:-**

The CHILDLINE is 24 hours (night & day) free phone outreach service, which can be accessed by a child in distress or anybody on behalf of child can dial the number 1098 on telephone. CHILDLINE provides emergency assistance to a child as soon as possible based on child's need.



The CHILDLINE service focuses on the needs of children living alone on the streets, child laborers working in unorganized sector, domestic workers and sexually abused children. The child is rescued & referred to an appropriate organization for long-term follow up and care. Main objective of the Programme is to contribute and work towards strengthening and participating in a global movement that addresses issues related to child protection and ensures that children's voices are heard.

#### **Activities:-**

- Responding to calls on the national toll free number 1098 and provision to rescue and offer emergency outreach services for children in need of care and protection.
- Coordinating rescue and other outreach services with the help of relevant local departments like police, administration, labour, health, railways and others.
- Ensuring proper documentation of all children rescued to facilitate their rehabilitation and restoration, where necessary.
- Producing children before the Child Welfare Committee (CWC) to ensure care and protection and supporting the CWC in the long-term rehabilitation of children, where required.
- Providing data related to children rescued and rehabilitated for the compilation of a national comprehensive database of child protection.
- Creating awareness and ensuring access to the 1098 Child helpline (CHILDLINE) number.
- Conduction of extracurricular activities like rangoli, drawing, dance competition among students for improvement of skills.

**Case Studies:****Rehabilitation of the distressed orphans**

This case belongs to village- Ukumbaguda, PS/Block- Gunupur, Dist- Rayagada where some accused person of the village including the support of villagers killed a couple named Gopal Sabar and Laxmi Sabar of this village mercilessly at village open space during night believing that the victims were practicing witchcraft and there by injuring villagers. The dead couples had two children at home one male child named Hemanta Sabar, aged about 12 years studying in class-6<sup>th</sup> at- Govt. high school, Kujendri and one female child named Shanti Sabar, aged about 13 years, studying in class-8<sup>th</sup> at-Govt. high school, Kujendri besides one married elder daughter. The financial condition of the victim family was not good as they used to work as agriculture labour fore their livelihood. After the death of the parents the two children became hopeless and

distressed. There was threat perception to their life and safety when complaint lodged against the accused by elder daughter at Gunupur police station.

After getting phone call from Gunupur police station, childline team, Rayagada intervened in the case and came to know that the victims are poor scheduled tribes and there is need of shelter, nutrition, safety and proper education to the distressed children. Childline, Rayagada received the children, counseled them to get rid of mental stress, prepared the required documents and report to produce before CWC, Rayagada along with proper communication to DCPU, Rayagada. At last Childline team, Rayagada succeeded in providing shelter, safety and education to the children channelized through CWC and DCPU, Rayagada. The female child was sheltered at SEVA SAMAJ (CCI) and continued her education at Municipality high school, Rayagada where as the male child was sheltered at Balniketan Gunupur (CCI) and continued his education at Gunupur High School. The children and their well wishers became thankful to Childline, Rayagada for timely action and proper rehabilitation.

### **Rescue of new born baby:**

An unmarried female of village Debdola, Po-Kumtelpetha, Ps-Chandili, Block/District-Rayagada involving with love affair has given birth to a male child at District Head quarter Hospital, Rayagada. She belongs to general caste and used to work as daily wage labour due to poor financial condition of her family. After getting phone call from DCPO, Rayagada, Childline, Rayagada intervened in the case, counseled the mother of the child and came to know that in fear of social shame and stigma because of unmarried birth case she was not interested to take the child at home and interested to surrender the child to Government. Through facilitation of Childline team the child was received by Government and handed over to Special Adoption Agency (SAA), Koraput. The female including her family expressed their gratitude and thanks to Childline, Rayagada for such cooperation and solving the case.

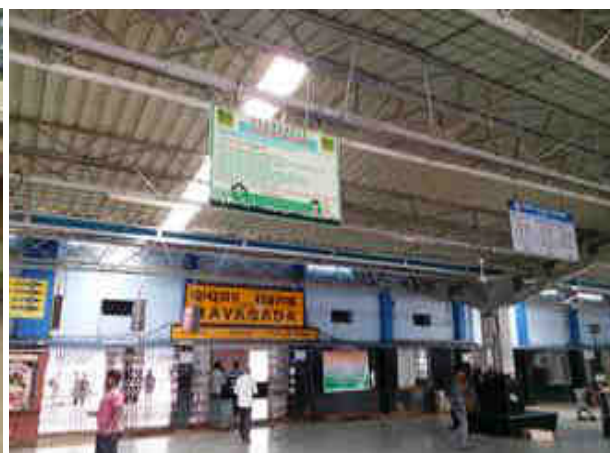

### **Senior Citizens' Home**

India is the second largest country in population explosion. Large numbers of people over the age of 60 are neglected in their families for getting better hospitality. Most of them are very poor and lives in rural areas. The elderly have little hope of escaping poverty and their situation only becomes worse as they get older and are increasingly plagued by chronic health problems. Impoverished elderly women face a particularly difficult situation, especially those who are widows. Given their low rank in society, their inability to work and they are unable to survive on their own.

#### **Aim & Objective:**

- To foster the welfare of the aged especially the needy aged, irrespective of caste or creed.
- To create in the younger generation and in society a social awareness about the problems of the elderly in today's Society.
- To create environment for senior citizen where they can live freely with dignity.

#### **Shakti's Effort for Aged Care:**

SHAKTI has been working on the issues of senior citizens for the last fourteen years. As a part of its effort for senior citizen, there are two types of initiative focusing on the elderly people in the Rayagada District i.e. Non- institutional care & Institutional Care.

##### **i). Non-Institutional Care:**

We have been serving the old age people in need. We are helping them to get old age pensions, legal counseling, and Cataract operations and helping them in enrolling in emergency feeding programme. Field staffs are visiting the elderly person in our operational areas; render counseling to them and their family members. We also provide them psychosocial care. We have conducted 23 meetings to create social awareness about the problems of the elderly people,

among the younger generation and in society. A total of 139 elderly persons got our services during last year.

## **ii). Institutional Care:**

Shakti has been running a Senior Citizens Home at Rayagada. The programme is funded by the Ministry of Social Justice & Empowerment, Govt. of India and aims to support the socio-economic development of disadvantaged older people by providing shelter, food, cloth and health care. Under this programme, the Senior Citizen Home has 25 strength for destitute and neglected elderly persons, who have nobody else to take care of them. This is a safe & secure place, where they can freely live with dignity. Senior citizens are supported with Shelter, Food, Cloth and Medical care at the Senior Citizen Home regularly.

## **Health Care:**

The Doctor visits the Senior Citizens Home once in a Week and conducts health check-up. Medicines are provided as per the prescription of Doctor. In case of any serious illness of inmate, we admit them in the Dist. Hospital. Besides weekly health check up one dental camp conducted during FY 19-20 where 6 nos. of inmates got benefit of the camp through dental extraction.

## **Others Facilities:**

Inmates are entertained by the television, Oriya Newspaper, story books, spiritual books provided by SHAKTI. All necessary commodities like hair oil, bathing soap are provided regularly to the inmates. Counseling service to the inmates was done by the counselor on regular basis.

## **Participatory Management:**

We encouraged the inmates to bring solidarity among themselves through decentralize the responsibility in a participatory management system in day to day activities of Senior Citizen Home. By the facilitation, they have formed following Groups to co-ordinate and management various responsibility smoothly.

- Subcommittee for Food & Cloth.
- Subcommittee for Yoga (Exercise), Meditation, Prayer & Religious discourse
- Subcommittee for Personal Decorum
- Subcommittee for Health & Personal hygiene
- Subcommittee for Sanitation
- Subcommittee for Social work & Recreation.

Continue assistance to the subcommittee and planning cum-review meeting held in every fortnight, the performance of subcommittee has upgraded.

As the project management team one Superintendent for overall management, one counselor, Midwife-Nurse, one Cook-cum-peon, two nos. of Multi Task Staff and one part time



Doctor also a part time Yoga Therapist are looking after the inmates of Senior Citizens Home. Our staffs are trained to be prompt, patient and sympathetic towards the inmates.

#### EXTRA CURRICULAR ACTIVITIES:

- **Yoga & Meditation** : Inmates are practicing Yoga & Meditation daily under the guidance of our trained Yoga Therapist.
- **Evening Walk** : Evening Walks are done daily by the inmates under the guidance of the Mid Wife nurse.
- **Health & Hygiene** : Inmates are cutting their nails every week & Hair once in a month. They are involved in keeping the surroundings clean doing some social work like road cleaning with the guidance of our project Coordinator.
- **Observed National Day & festival:** Inmates observed Independent Day, Republic Day, and Holi etc to build up nationality & brotherhood relationship.

#### **CASE STUDY:**

A woman named P. Appayama lived in Indiranagar, 4<sup>th</sup> Lane, Rayagada. She was a widow and having one daughter. Her husband was a wage labour and after his death the lady was hopeless with her single daughter, used to work at nearby houses and managed her family with hardship and struggle. When her daughter came to the age of marriage she finished the marriage ceremony of her daughter by selling the house of her predecessor. After that, the situation of P. Appayama was too critical and misery. Her own daughter didn't ask her after marriage. With continue distress Appayama gradually lost her sight due to cataract. She was unable to work and to manage her food. She was only dependent on the offering of food by kind hearted people who had compassion on her. At last she was placed at Govt. Shelter Home, Rayagada. One day Staff of Shakti Organization found the case while in a visiting to Shelter Home and came to know detailed painful story of Appayama. They immediately shifted her to SHAKTI-Senior Citizens' Home situated at Housing Board Colony, Rayagada where priority has been given for institutional care of destitute senior citizens to avail them a dignified life. Appayama



was gone through a successful cataract operation at LV Prasad Eye Institute, Rayagada by facilitation of staffs of SHAKTI-Senior Citizens' Home. Now at the age of 66 she is able to see and maintaining a dignified life at the Senior Citizens' Home. When she was asked about her feeling at SHAKTI-SCH, with a smile at her face she told that, even if my daughter will come to take me with her, I will never leave this home because throughout a hardship and struggle life I am obtaining a new peaceful and happy life at this place.

### **Senior Citizens' Home for 50 elderly women**

Similar to Senior Citizens Home with an aim of fostering the welfare of the aged women especially the needy elderly widows, SHAKTI has also managing a Widow home where 50 needy elderly widows are being supported with food, clothes and shelter including regular health check up. Along with the support of basic needs to the widows, regular yoga, meditation, morning and evening walk, recreation activities, celebrations of National festivals, memorable days are always organised there to keep them happy and healthy. Emphasis has always been given to offer a happy and dignified life to the inmates at their distressed old age.

### **Secondary level Educational Complex for ST Girl Students**

Shakti is managing a 100 seated Secondary level Educational Complex for the welfare of Scheduled Tribe girl students at Rayagada urban area including schooling and boarding. Students are taken proper care including free education, lodging, food, uniform, books and recreation in leisure hours through playing TV and indoor games.



## Maternity Waiting Home

### Goal-

Goal of this Project is to provide institutional care to pregnant women of remote areas for their safe delivery at Hospital to reduce mother and child mortality.

### Reduction in mother and child mortality:-

Institutional care of mother is very much necessary in remote tribal belt areas for safe maternity where majority of the women are illiterate, believing in superstitions and facing hurdles to go to hospital due to communication problem. One maternity waiting home (Maa Gruha) is running by SHAKTI Organization under NRHM Scheme at Kashipur Block of Rayagada District. This Block of Rayagada District is well known as dominated area of poor rural indigenous tribal mass who believes in traditional superstitions instead of hospital for check up, treatment and delivery. SHAKTI Organization has accepted the challenge in motivating the pregnant women of such villages to stay at Maa Gruha and to ensure their safe delivery at Hospital thereby reducing mother and child mortality. Pregnant women 10 days before delivery date are invited to stay at Maa Gruha with an escort till their safe delivery. They were served with free lodging, fooding, regular check up by ANM, counselling through IEC materials by Lady Health Assistants and assisted by the Maa Gruha staffs in every aspect till their delivery. At Kashipur Block during FY 19-20 total 252 cases admitted at Maa Gruha covering 10 remote GP of Kashipur such as Mandibisi, Godibali, Siripai, Adajore, Sunger, Renga, Talajhiri, Chandragiri, Manusgaon, Maikanch with 16 Sub-centre which include 228 villages. Cases from remotest area where movement of vehicle is difficult and from destitute families are always given more priority to ensure their safe delivery.

### Case Study:

Kemeldei Majhi, W/O- Kalesing Majhi, village- Pottesh, GP/Po- Mandibishi was one of the cases of MWH, Kashipur during 2019-20. This village of Kashipur is one of the remotest villages with lack of proper communication route to main road. Kalesing Majhi used to work as daily wage labour and most of time remains outside of house in search of work. The financial condition of the family was poor and estimated to less than 50,000/year. Kemeldei Majhi had bitter experience of giving birth to baby who has succumbed to death within 6 month during her first delivery case. In the second delivery she had given birth to a girl child and this was the third delivery of Kemeldei Majhi. Lack of proper nutrition, care and communication route is the main reason of infant and mother mortality in the area. Staffs of MWH, Kashipur after getting information regarding the case reached at the place, counseled the family members regarding benefit of staying at MWH, available facilities and ensure them for safe delivery of the infant. Facilitated by staffs of MWH, the case arrived at MWH, Kashipur with her mother in law and little daughter through 108 ambulance, stayed continuously for 15 days, obtained all available facilities of MWH like lodging, proper nutrition, knowledge on maternal issues and infant care, regular health check up and at last she had given birth to a girl baby at CHC, Kashipur successfully. The health condition of both mother and baby was good. While leaving Maternity Waiting Home, Kemeldei Majhi expressed her gratitude towards MWH for the proper institutional care that she has been provided during her stay at MWH which is the reason of her safe delivery at Hospital.

### The Hunger Project

The objective of The Hunger Project is to empower women elected to local Government in Panchayats to meet the development needs of their communities. The programme covers entire Ramnaguda Block. Under this programme 3 nos. of clusters have been formed taking women PRI members like Ward member, Sarapanch, Naib Sarapanch at Parikhiti, Ukumba and Kujendri. One Mahasangha named Aliva Mahasangha have been formed including the women

PRI members. Programmes related to meetings, workshops, trainings, campaign have been conducted for capacity building of the women PRI members for active participation in the PRI system. The details of the activities conducted during 2019-20 under this project are listed below.

### SHAKTI Rural Development Training Centre (SRDTC)

Training of Asha workers is too much essential who works as an interface between the community and public health system and plays important role as community level care provider. During FY 19-20 total 19 nos. of Bridge training on HBYC (Home based care of young child) conducted at the training centre situated at Ramnaguda where total 617 nos. of Asha and



Anganwadi workers participated from 4 Blocks of Rayagada District such as Muniguda, Rayagada, Kolnara, Bisamkataka. Similarly total 16 nos. of 5 days Asha training conducted at the training centre where 511 nos. of Asha participated from 5 Blocks of Rayagada District such as Rayagada, Muniguda, Gunupur, Kolnara, Kalyansingpur. In this way total 35 nos. of training programmes conducted at the SRDTC during FY 2019-20 where total 1128 Asha and Anganwadi workers participated from 6 Blocks of Rayagada District. Along with fooding facility the participants were provided travel allowance for participating at the training programme. Both trainer and trainees were also provided with necessary well accommodation facilities at the SRDTC premises. Master Trainers from District Hospital participated as Resource Persons.

Operational Area- Four Blocks of Rayagada District such as Kolnara, Ramnaguda, Gunupur, Padmapur

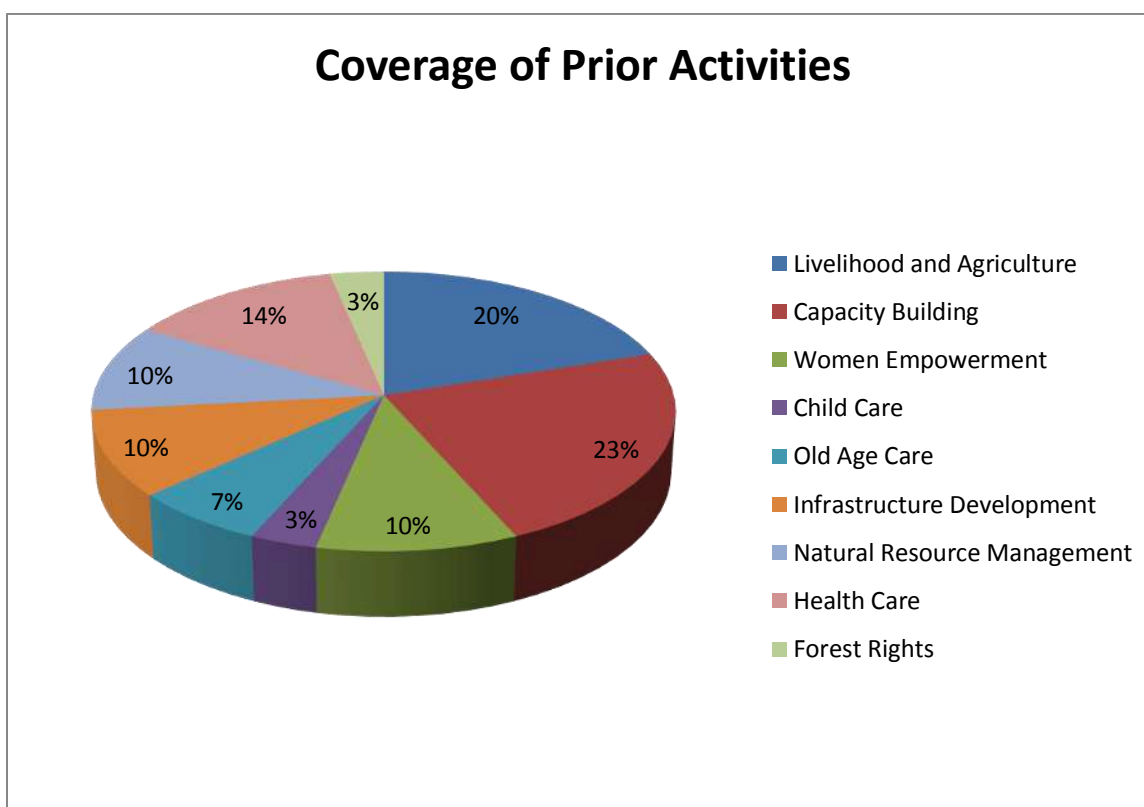
